Introduction

At Micheldever & Stratton Preschool we have responsibility to ensure the safety and welfare of the children in its care. The wearing of jewellery may pose a risk of injury to both the wearer and those around them, especially necklaces and earrings which may become tangled or caught on equipment and clothing. The loss of a valuable item may also cause upset.

Procedures

Through this policy we aim to:

- Ensure the safety of all children
- Prevent the loss of valuable items at the pre-school
- Show respect for the beliefs of the children and their families

It is the policy of Micheldever & Stratton Preschool that no jewellery will be worn by the children.

Where jewellery is required for cultural / religious / medical reasons parents are to notify the pre-school that the jewellery is being worn to enable a risk assessment to be undertaken; upon receipt of a signed consent form such jewellery will be allowed.

Where a member of staff notices that a child is wearing jewellery and the consent form has not been returned, they will assist the child in removing the jewellery and place it in the safe until the child is collected at which point it will be returned to the carer.

The preschool will not be liable for the loss or damage to any jewellery brought onto the site. Micheldever & Stratton Preschool has a responsibility to ensure the safety and welfare of the children in its care.
